Program is offered on Wednesday's & Thursday's 400:pm- 5:00pm

Several days can be extended for addition time completing work independently, but it MUST be prearranged and pre-approved.

2nd Child Discount: -\$5 off for Monthly or Drop-In

Ages 5-15 may be dropped off. Children under age of 5 will need to be accompanied by an adult.

Membership is set up for your debit or credit card to be reoccurring payments auto-drafted from our processor on the 1st of the month. You can cancel anytime but we ask that you give a 2 weeks notice and try and stay through the 4 month term to be included in their big public art exhibit. (Held twice a year in April and September.) Please fill out Credit Card form at the end for Membership enrollment or you can sign up for Drop- In classes on our website.

Waiver & Release

Consideration: I acknowledge the personal benefits accruing to my child by reason of participation in the above described event and am aware of the activities which my child will be involved through said participation.

Release / Indemnification: I hereby, in consideration of such benefits and other good and valuable consideration received, consent to the above listed participation and release absolutely, forever discharge, hold harmless and covenant not to sue Studio Cellar, LLC, and program location, its directors, employees, agents, volunteers, and affiliates ("House of Art, LLC") from any and all present or future liability, claims, demands, actions or rights of action, whether asserted by me or a third party arising out of my child's participation in the event activities (the "Claims").
